Executive Order No. 302

AMENDING EXECUTIVE ORDER NO. 297, DATED **DECEMBER 24, 1949**

BY virtue of the powers vested in me by Republic Act. No. 330, entitled "An ACT AUTHORIZING THE PRESIDENT OF THE PHILIPPINES TO ESTABLISH A SYSTEM OF IMPORT CONTROL BY REGULATING IMPORTS OF NON-ESSENTIAL AND LUXURY ARTICLES, CREATING AN IMPORT CONTROL BOARD, AUTHORIZING THE ISSUANCE OF RULES AND REGULATIONS TO CARRY INTO EFFECT SUCH CON-TROL AND PENALIZING VIOLATIONS OF THIS ACT,

ELPIDIO QUIRINO, President of the Philippines, do hereby order: SECTION 1. Section 2 of Executive Order No. 297 is hereby amended to read as follows:
