

# Con las bombas de aviones enemigos llegan "regalos" utiles a los nipones

Desde una base japonesa en Birmania, 3 de abril.—Ademas de realizar destructores ataques contra el enemigo, nuestras fuerzas estan disfrutando de "regalos de la Casa Blanca" que los aviones enemigos dejan caer a intervalos. Estos "regalos" incluyen bombas incendiarias, paracaídas y alimentos.

En cada una de las bombas enemigas se encuentran numerosas bombas incendiarias que vienen a ser un buen sustituto para la leña. Después de cada raid nuestros mandos hacen una recorrida para recoger los trozos arrojados de las bombas y que sirven para hervir agua. Con una libra de esta "combinación" del enemigo, un lambi leng de agua puede ser hervido facilmente, permitiendo a muchos soldados disfrutar de un buen caliente.

Con cada avion enemigo abatido por nuestras fuerzas dos o

tres pilotos enemigos llegan a tierra en paracaídas. Después de capturar a los paracaidistas enemigos, nuestras fuerzas cortan las paracaídas en pequeños pedazos y hacen ellos buenos pañuelos, toallas y hasta camisetas.

Con respecto a los alimentos, los aviones de transporte enemigos suelen arrojar a hurtadillas dejando caer alimentos destinados para tropas enemigas que han descomulgado fuertemente de los aviones. Sin embargo, como las tropas enemigas fueron dispersadas por la fuerza avalancha de nuestras fuerzas y los transportes enemigos temen ser descubiertos ellos dejan caer rapidamente sus provisiones y huyen.

Como resultado, muchos provisiones han caido dentro de las lineas japonesas. Los alimentos incluyen la carne de loro en lata, hinchada y otras cosas agradables al paladar.

## Unos demócratas en America quieren control "blanco" sobre las elecciones

Libros, 5 de abril.—Un despacho de Nueva York dice que los demócratas reaccionarios de los estados del sur han expresado una vehemente oposicion a la decision de la Corte Suprema de los Estados Unidos, anunciada ayer, en el sentido de que los negros tienen derecho en las elecciones primarias a nominar candidatos para el congreso, dando pruebas asi de su firme determinacion de conservar el control "blanco" sobre la maquinaria electoral.

Los caudillos demócratas de los estados del sur expidieron una declaracion alegando que la decision viola los "derechos del estado", perjudicando las relaciones interraciales predominantes en el sur y amenazando crear una grave situacion.

Los informes de Washington dicen que la decision de la Corte Suprema ha levantado la posibilidad de que algunos estados del sur abandonen el sistema de las elecciones primarias y vuelvan al metodo de seleccionar candidatos politicos mediante convenciones.

El Senador John H. Overton, demócrata de Louisiana, indico tambien la probabilidad de que se abandonen las elecciones primarias para "sostener la regla de la supremacia blanca."

Nueve aviones fueron abatidos por los nipones

(Especial de LA VANGUARDIA)

Tokio, 5 de abril.—Con las decisivas batallas navales entre las fuerzas japonesas y las anti-Eje intensificandose en todo el frente del Asia Oriental Mas Grande, los torpedos del brazo aereo del Ejercito japonés durante el mes de marzo ultimo revelan un aumento comparado con los del mes de febrero.

Como habian anunciado los Cuarteles Generales Imperiales esta tarde, las flotas aguilas del ejercito abatieron 321 y dañaron gravemente 186 aviones anti-Eje el mes pasado. Estos triunfos corresponden a un aumento de 80 aviones comparados con los del mes de febrero ultimo, durante el cual la fuerza aérea del ejercito abatió o dañó gravemente un total de 407 aviones.

De lamentable en este respecto que nuestras perdidas el marzo ultimo—44 aviones que se lanzaron los objetivos enemigos o que no han vuelto aun a sus bases y otros 49 que fueron seriamente dañados el suelo, haciendo un total de tambien aumentaron en 13 comparadas con las de febrero durante cuyo tiempo perdimos 80.

El numero de aviones anti-Eje que atacaron diferentes puntos en el frente del Asia Oriental Mas Grande durante los dos meses demuestran hostilidades navales intensificadas y areas de combates en el aire mas concentradas.

Sobre China, los atacantes au-

mentaron de 160 en enero a 188 el febrero ultimo y luego a 383 en marzo ultimo, demostrando claramente que la ofensiva anti-Eje ha aumentado gradualmente, particularmente en el aire. Se ha dado cuenta de que varios bombarderos Boeing B-29 volaron recientemente a Kweiling, provincia de Yunnan, con vistas a reforzar al 14.º cuerpo aereo americano en China.

Por el contrario, sobre Indo-China, Francia, Tailandia y la region noroeste, los atacantes anti-Eje el marzo ultimo disminuyeron en 50 comparados con los del mes de febrero. La razon es que el campo anti-Eje ha tenido que usar no solamente aviones de transporte sino tambien muchos de sus bombarderos y aviones de combate para el transporte de provisiones y para el rescate de tropas paracaidistas que descendieron en el sector de Katha en Birmania.

Sobre Nueva Guinea, por otra parte los atacantes anti-Eje el marzo ultimo aumentaron en unos 400 comparados con los de febrero, simultaneamente con la intensificacion de las hostilidades en tierra.

Sobre la isla de Bougainville, los atacantes abundantemente aumentaron en 1,754, de 4,296 en febrero ultimo a 6,050, en marzo ultimo, afectados por la positiva accion de las fuerzas japonesas de la isla sobre la poscion fortificada anti-Eje en el Cabo Torokina, lanzada a principios de marzo. Se ha demostrado que la fuerza aerea anti-Eje en el sudoeste del Pacifico concentro su fuerza en el rescate de los defensores de Torokina.

El Netaji declaro que una institucion que este en contra de este principio tiene que desaparecer. Los indios que han estado dejando llevar por el individualismo, ahora salen al frente para contribuir con sus esfuerzos a los intereses de todo el mundo, dijo el Netaji, añadiendo que en Nueva Birmania, durante los ultimos meses, los indios han expresado su voluntad de ceder todo cuanto poseen al gobierno provisional.

Declaro: "Ayer el indio mas rico de aqui me hizo entrega de un cheque en blanco y una declaracion de su cuenta en el banco, diciendome que escribiera la cantidad que quisiera. Responde que una vez que la influencia extranjera fuese eliminada de la India, los indios serian contentos al frente para cooperar.

Los dos proclamas del gobierno provisional

Refiriendose a las dos proclamas expedidas por el gobierno provisional, el Netaji aseguro que la primera proclama ejercitaba al pueblo indio que iba a la India, le protegeria, advirtiendole al pueblo indio lo que debia esperar y no dejarse enganar por la propaganda inglesa. Dijo que durante la campaña de Birmania, los ingleses iniciaron un fiero movimiento de propaganda que hizo que 500,000 indios evacuasen esterilmente Birmania.

Los ingleses podrian intimidar a las masas indias para que destruyan todo y huyan diciendoles que van a ser muertos.

El ejercito nacional indio captura Timah

Desde el frente sur indio-birmanés, 3 de abril.—Las unidades aereas del ejercito nipon, en el curso de dos raids sobre un aerodromo enemigo cerca de Indav, en la parte superior de Burma, causaron destrucción en los aviones enemigos así como en sus instalaciones terrestres.

Una formación de bombarderos japoneses de pié en el aerodromo al noroeste de Indav donde descendieron las tropas aereas enemigas en la noche del 3 de abril y en el amanecer del 4 de abril.

Tan pronto como los aviones japoneses llegaron sobre el "blanco" de los cañones anti-aerios del enemigo abrieron fuego con un fuerte barrage, pero los bombarderos nipones conservando su perfecta formación se lanzaron sobre el aerodromo y a las 10 millas de Indav
