BYDLANATORY NOTE

This bill is but the reelection and crystalization of the wishes of the inhabitants of Santa Rosa, Kaubian, Panwishes of the innabitants of Santa Rosa, Raubian, Pan-gan-an, Caojagan and Sulpa islands which are flung in the middle of the ocean midway between Cebu and Bohol and far from the mainland of Cebu and the mainland of Mactan. The reasons behind the bill are various.

GEOGRAPHICAL. The islands of Santa Rosa, Kaubian, and GEOGRAPHICAL. The islands of Santa Ross, Kaubian, and their neighboring and sister islands are over ten miles distant from the mainland of Opon. The wide stretch of water that separates said islands from Opon works a terrible hardship on the inhabitants of said islands. During stormy weather their lot becomes very hard indeed. There is no steamboat or even a launch that periodically comes to said islands. The barrios in said islands are almost isolated and

islands. The barrios in said islands are almost isolated and out of from the población of Opon.

ECONOMICAL. The proposed municipality of Lapulapu has a sufficient number of inhabitants and extent of territory and taxable property necessary to constitute an independent municipality. It has an approximate area of 700 hectares. Its population is approximately 5,000. It has a taxable property worth P111,180. At present, about P5,000 are collected from the inhabitants of said islands as real property and personal taxes, internal the requirement of the property and personal taxes, internal the property control taxes, internal the property and personal taxes, internal the property of the property of

No INSULAR DEBTS. Another good reason that entitles the said islands to form themselves into an independent musaid islands to form themselves into an independent mi-nicipality is that the present municipality of Opon owes nothing to the Insular Government. The only debt it owes is \$\mathbb{P}4,500\$ to the Province of Cebu.

FINANCIAL STANDING OF OPON. Still another strong reason ATMANCIAL STANDARD OF OPON. Still another strong reason that justifies the constitution of an independent municipality of those islands is found in the fact that the municipality of Opon has an annual gross income of about #90,000 general fund and #10,000 school fund. The Muncipal Council of Opon indoress the idea behind this bill, by its Resolution

PRESENT FACILITIES. There are two big barrios, Santa Rosa and Tingo, any one of which can be the seat or the capital of the municipality. They have the necessary men capable of taking over the administration of the affairs of

the proposed municipality.

MATTER OF JUSTICE. Santa Rosa or Oango group of islands was for time immemorial enjoying an independent existence as a municipality until 1904, when it was fused with the municipality of Opon. Cordova had likewise been a municipality; but like Santa Rosa, was fused with the municipality of Opon. But in 1913, Cordova got back its municipal independence. Santa Rosa did not. Cordova is right in the mainland, on the islands of Mactan, but a few kilometers from the población of Opon. On

the other hand, a wide gulf separates Santa Rosa, and the adjacent islands from the mainland of Mactan. So Santa Rosa and her sister islands and barrios have better reasons to be reconstituted into an independent municipality. Hence the just demands that they be given back their lost municipal independence.

The Municipality of Opon shall consist of its present territory, less the territory comprised by the Islands of Santa Ross, Kaubian, Pangan-an, Caoigaga, and Sulpa. SEC. 2. All the provisions of the Administrative Code, as amended, which are applicable to the regularly organized municipalities, shall govern the new municipality of Lapulapu. SEC. 3. The funds and obligations as well as the properties

SEC. 3. The funds and obligations as well as the properties that pertain to the municipality of Opon shall be equitably distributed between both municipalities of Opon and Lapulapu in the form and manner recommended by the Insular Auditor and approved by the Governor-General.

SEC. 4. The elected municipal officials of the newly organized municipality of Lapulapu shall be appointed, as soon as this Act shall have been approved, by the Governor-General with the consent of the Philippine Senate upon the recommendation of the Provincial Board of Cebu and shall hold office until their successors are duly elected and qualified in accordance with the Election Law.

SEC. 5. The organization of the municipality of Lapulapu shall not affect the political organization of the municipality of Opon, and its present municipal officials shall continue to hold their offices until their successors shall have duly qualified.

SEC. 6. This Act shall take effect on its approval. Approved.

It is proposed in the attached bill to create an additional municipality in the Province of Masbate. It will be formed out of these remote barrios now belonging to the municipality of Milagros and will be called the municipality of Balud. Said barrios are located in isolated regions about thirty kilometers from Milagros. There is no road connecting them with the población. The places lying between these barrios and Milagros are isolated and during rainy season are almost impassable. For these reasons the inhabitants of the barrios are not only denvived of a ready notice profession and research. are not only deprived of a ready police protection and prompt municipal health service but also are rendered helpless to

municipal health service but also are rendered helpless to regularly transact business with the municipal government. The establishment of the new municipality of Balud will not only secure protection to life and property in Balud and nearby barrios but will also open the way toward a rapid development of the regions in the western part of Masbate. In view of the above reasons the enclosed bill is submitted

to the House for approval.

EXPLANATORY NOTE

The purpose of the attached bill is to reëstablish the former municipality of Tagana-an which has been in existence during the Spanish regime until the year 1905 when its territory was divided between the present municipalities of Surigao and Placer by the annexation of the barrio of San Jose and the sitios of Kabongbongan, Navago and Panalsalan to Surigao, and the barrios of Tagana-an, Talavera, Bamban, and Himamaug to Placer. The interest and welfare of these barrios demand that they be organized as in former times into one independent municipality. These barrios are very far from the municipalities of Surigao and Placer and the only means of communication is by sea, which is often times perilous. Due to their distance from either Placer and the only means of communication is by sea, which is often times perilous. Due to their distance from either the municipality of Surigao or Placer the said barrios have neglected and its was rare that the same were given any amount for public works by the mother municipalities. It is for these reasons that the inhabitants of the above named barrios have always been clamoring for separation from the municipalities of Placer and Surigao, and for their organization into one independent municipality in order to be able to attend properly to their own affairs and interests and to do all the improvements possible within their own territory.

territory.

The proposed municipality of Tagana-an has a population of four thousand people and counts with sufficient income to maintain and support the administration of local government. At present the municipality has a municipal building ment. At present the municipality has a municipal building with a plaza of one hectare in front, a concrete school building likewise with its corresponding plaza of one hectare, a municipal cemetery and a site near the bank of the river especially appropriate for a market, all of which are owned by the barrios of Tagans-an.

Approval of this bill is urgently recommended.
